Background & History

Wells Cathedral Oratorio Society performs major choral and other works in Wells Cathedral several times a year – and sponsors a "Come and Sing" day in the spring of most years.

It can trace its existence back to at least 1863 as the "Wells Music Association" – and during the 20th century it joined forces with the Street, Shepton Mallet and Wedmore Musical Societies.

The chorus is drawn from a wide area in Somerset and is one of the leading choral societies in the South West of England.

The Society contributes significantly to the cultural life of Wells and the surrounding area, and we are proud of our efforts to reach out to all music lovers through a wide choice of music, some of which is rarely heard.

Our Come and Sing Day provides for those local and other singers from further afield to come and enjoy with us perhaps a new opportunity and experience in choral singing and is much appreciated.

Objects of the Society

The Society is a registered charity – which, despite its name, is independent of Wells Cathedral. The Society's objects, as defined in its Constitution, are:

- To educate the public in the art and science of music and, in particular, the art and science of choral music by the presentation of choral concerts and other related activities.
- To assist and further such charitable institutions and purposes as the Committee shall from time to time determine.

Public benefit

The Committee (whose members are the Trustees of the charity) have complied with their duty to have due regard to the guidance on "public benefit" published by the Charity Commission when exercising their powers and duties.

Management

The Committee of the Society makes arrangements for concerts and other related events and management of the Society's affairs and the control of finance.

Committee members are drawn from the membership of the Society and stand for election every year. Committee members who served at the end of the period are listed on Page 12.

The Committee is ably supported by specialist volunteers to whom we extend our appreciation – also listed on Page 12.

Review of the year

Chairman's report

Review of the season 2022/2023

The 2022-23 season has been busy with various changes and additions to our usual schedule of concerts. Returning to rehearsals in October 2022 meant our first actual concert of the season was the December Messiah which proved to be a tremendous success. Whilst having a full cathedral was wonderful the lengthy queues to attend the concert were not ideal and the committee are exploring ways with the cathedral events team to prevent this situation reoccurring.

As always it was a privilege to perform with the Music for Awhile orchestra led by Maggie Faultless.

This event was tinged with sadness as it was to be Jeremy Coles' final concert with WCOS as he was leaving Wells to explore pastures new. Jeremy was thanked for the excellent work he did with the choir and a warm welcome was extended to Alexander Hamilton appointed as Acting Director of Music. We are grateful to the cathedral who kindly arranged for Alexander to be temporarily relieved of responsibility for managing the Cathedral Chamber choir and free his busy schedule to allow him time to act as conductor of WCOS.

2022/23 season

The Rutter Magnificat & Faure Requiem were performed in March 2023 successfully led by Alexander Hamilton.

Not having had a concert in November and to ensure the choir had the opportunity to perform three concerts for the season an invitation was accepted to participate in the cathedrals Sound of Wells weekend in May 2023 performing a selection of music to celebrate the coronation.

A "Come & Sing" event rehearsing and performing Verdi's Requiem led by conductor Nigel Perrin was held in the cathedral on June 3rd closely followed by a final performance of a Proms style event on behalf of the Friends of Wells cathedral on June 9th to help celebrate their 90th anniversary.

The collaboration between WCOS, the music foundation and Friends of the Cathedral proved to be very successful and much appreciated by the Friends.

Future concerts

Looking to the future the Committee recognised the choir's desire to return to a regular season of concerts running from September to March. With that in mind rehearsals are planned to resume in September 2023 to rehearse a selection of choral classics to be performed in November followed by a performance of the Messiah in December.

For March 2024 arrangements are underway to perform the much loved Elgar's Dream of Gerontius.

Although tentative plans are being made for the 2024/25 season this may be influenced by the cathedrals plans to recruit and appoint a new, permanent Director of Music in 2024.

PUBLICITY

The main publicity media used during the year have been personal recommendations by members, posters in public places (e.g. shop windows, libraries, churches, notice boards etc) and free advertisements in local press.

In addition the Cathedral Box Office ensures our concerts are advertised alongside their other events on a variety of websites and the Dean helps ensure our concerts are promoted in the Cathedral Newsletter.

The Society made increasing use of its Facebook page during the year, including some paid promotions – and of its email mailing list.

Unfortunately we have not been able to access the email addresses of ticket buyers since we started using the Cathedral's Eventbrite system.

FUTURE PLANS

In making plans for the next season (2022-23 and beyond) the Committee has endeavoured to balance the ambition to present attractive concerts with the Society's limited financial resources, a change of conductor and the general economic situation in the country – whilst maintaining the high standards that the choir is known for.

To this end Peter Lawrence, our new Chair, has initiated consultations with members and others about the direction the choir should aim for the next decade.

FINANCIAL REPORT

Accounting system & reporting basis

During the year the Society's accounts were transferred from a manual Excel system to a widely-used online system called "Xero".

Also during the year the Committee agreed to return to the "accruals" basis, where income and expense items are posted when they are due, rather than when they are paid (which can be weeks or months later). This provides a clearer picture of the state of the Society's finances at any time.

(The net impact on the accounts for 2021-22 of this change was small – i.e. the "late" receipts and payments balanced out to within £160.)

Income & Expenditure

Income for the year to 30^{th} June 2023 was £53,839 and Expenditure was £43,547, resulting in a surplus for the whole year of £10,292.

This surplus is added to the Reserves built up in previous years (amounting to £14,234 at the beginning of the year) – increasing the Reserves at the end of the year to £24,526.

This compares well to the Society's target reserves of £22,000 (see Page 11 below).

Income

The main sources of income were:

Income from ticket sales increased substantially compared to the previous year – when the Messiah was performed free of charge.

(The amount spent on "Publicity" (i.e. printing posters & flyers) is relatively small, and could be increased if it would result in more ticket sales.)

There was also "overhead" (i.e. non-Concert) expenditure totalling £2,017 – which includes web site hosting, public liability insurance, postage etc.

NOTES TO THE ACCOUNTS.

Basis of Accounting

These accounts have been prepared on the Accruals basis – meaning that income and expenditure transactions are accounted for on the due date in each financial year.

Comparative figures for 2021-22 have been restated on the same basis.

Reserves Policy

The Committee reviews the level of Reserves from time to time to ensure it has enough funds to ensure its future, whilst not accumulating unnecessarily large balances. The Committee takes the view that the minimum level of Reserves should:

- (a) provide a short-term cash flow buffer for the first concert in each season, e.g. to book an orchestra and soloists before membership subscriptions and Gift Aid have been received.
 - The Committee's assessment of the minimum currently required for this is £15,000.
- (b) provide for a loss on concerts greater than forecast, for example catastrophic ticket sales after all expenses have been incurred, e.g. rehearsals, music hire etc.

 The Committee's current assessment of this additional risk is £7,000.

Therefore the minimum level of reserves required to cover (a) and (b) is £22,000.

When it is possible to accumulate greater reserves this will provide funds for concerts demanding large resources.

Current reserves

The Reserves on 30th June 2023 were £24,526 – which is above the policy target. The Committee will continue to carefully plan future seasons to maintain the target amount as far as possible.

Report of the Independent Examiner to the Trustees of Wells Cathedral Oratorio Society

I report on the accounts of Wells Cathedral Oratorio Society for the year ended 30 June 2023

Respective responsibilities of Trustees and Examiner

The charity's trustees are responsible for the preparation of accounts. The Trustees consider that an audit is not required for 2022-23 under section 144 (2) of the Charities Act 2011 ("the Act") and that an independent examination is needed.

It is my responsibility to:
